Dear Wyandotte Citizen:

Wyandotte Nation values the education of all Tribal Citizens and understands they have faced challenges related to distance learning during the COVID-19 public health emergency. Most, if not all, schools closed during the spring semester of 2020, which forced students to continue their education via distance learning on a computer. Many schools remain closed. We are taking action to facilitate compliance with COVID-19-related public health measures, such as expenses to facilitate distance learning, including technological improvements, in connection with school closings to enable compliance with COVID-19 precautions. Using CARES Act funds afforded the Tribe, we are providing a maximum of \$700 towards the purchase of, or reimbursement for, a computer, such as a Chromebook, desktop, iPad, laptop, or Tablet. We have determined that the expense of ensuring our Tribal Citizens have access to computers in order to facilitate their distance learning is a necessary cost arising from the COVID-19 public health emergency.

**Requirements for Services Program include:**

1. Signed and dated application for assistance verifying your need for a computer to facilitate distance learning resulting from the COVID-19 public health emergency;
2. Wyandotte Nation enrollment number;
3. Proof of enrollment in school or educational institution (e.g. class schedule); and
4. Receipt of computer purchased on, or after March 1, 2020 (if requesting reimbursement).

The following application is for any Wyandotte Nation citizen attending or enrolled in any educational institution.
